- A. That the accused /petitioner is innocent and falsely implicated in the above mentioned case.
- B. That there is no disinterested ocular or circumstantial evidence against accused / petitioner.
- C. That no recovery has been affected from the possession or on the pointation of the petitioner Inspite of the fact that the petitioner remained in Police custody for sufficient long time.
- D. That medical report does not support the prosecution version.
- E. That the report of FSL regarding the 30 bore pistol received in negative.
- F. That there is further scope of inquiry into the guilt of the accused / petitioner, moreover the petitioner is no more required for further investigation.
- G. That there is no apprehension of the abscondance of the accused / petitioner or tampering with the prosecution evidence.


It is therefore, prayed that by accepting this petition the petitioner may be released on bail till final disposal of the case.
