- **Peshawar High Court Promotes 30 Judicial Officers.**
- **In pursuance of recommendations of Administration Committee, Hon'ble the Chief Justice Mr. Justice Yahya Afridi promoted two Additional District & Sessions Judges as District & Sessions Judges, 12 Senior Civil Judges as Additional District & Sessions Judges and 16 Civil Judges-cum-Judicial Magistrates as Senior Civil Judges.**

After two days of deliberation and keeping in view the individual performance, Administration Committee of Peshawar High Court considered cases of Judicial Officers for promotion.

Notification for promotion has also been issued on Monday. Through another notification expected shortly, the promoted officers are given new postings. This is also added that Six Additional District & Sessions Judges will shortly be recruited from the lawyer's community through a process which will be initiated soon. Hon'ble Chief Justice, Peshawar High Court has also directed that Provincial Public Service Commission should immediately be approached for filling up vacant positions of 49 Civil Judges/Judicial Magistrates.

The posting of the newly promoted Judicial Officers is expected to ease work pressure and tackle growing pendency in different districts. It will bring efficiency and fast disposal of judicial cases.
